all scholarship. It is important that researchers give credit so readers can trace the ideas presented back to the sources. In fact, giving credit to experts and authoritative sources gives your conclusions validity that cannot be achieved by simply stating ones own opinions. Many databases allow you to export citations directly to EndNote. Users need to set up a free account to store their references. Quotes from sources should be used to bolster your ideas. Other peoples ideas need to be credited as well as their quoted words.
